MTNL Management had offered Group Health Insurance Scheme (GHIS) for MTNL working employees w.e.f. 14.06.2023 for a period of two years on tender terms and conditions to M/s UIIC Ltd. The policy for the period 14.06.2024 to 13.06.2025 is expiring on 13.06.2025 midnight.

As per the approval of Competent Authority, the said policy has been renewed with M/s UIIC Ltd. for one year for the period **14.06.2025 to 13.06.2026** as per existing terms and conditions with total insurance cover of Rs. 8 lakh (Rs.2 lakh Sum Insured + Rs.6 lakh Super Top Up) with revised premium. The renewal of scheme will take effect from **14.06.2025** for one year.

Accordingly, the indoor part of the Scheme will continue to be served by M/s UIIC Ltd. through the existing TPAs in Delhi & Mumbai Unit till finalization by the Insurance Company as under:

The Primary Agreement, Tailormade Health Insurance Policy, MTNL Working employees GHIS already signed between MTNL and M/s UIIC Ltd. and Tripartite Agreement already signed between MTNL, M/s UIIC Ltd. and all TPAs will be valid for the period 14.06.2025 to 13.06.2026 also.
