Kindly recall our discussion held with your good self on pending HR issues on dated 17-06-15. I am reproducing the discussion for your kind consideration and expeditious actions on the issues discussed.


1. **JTO to SDE DPC**--All preparations for DPC have been completed and DPC is scheduled to be held on 22nd June 15.
2. **AO to CAO**--After JTO to SDE DPC and before 30th June 15, DPC for AO to CAO will be held.
3. **JAO to AO**--In order to get sufficient number of posts in AO cadre, DPC will be held after the promotion orders are issued for promotion from AO to CAO in the month of early July
4. **RRs of DM(HR/Mktg /legal/CS)**-- HR unit will hold meeting to formulate a formula to fill up the post of DM in these streams and then case will be put up for RR approval.
5. **Financial up gradation from due date if no case pending on that date but case erupted before DPC**--Board note has been prepared and will be put up in next board meeting for its approval.
6. **Counting Training period for withdrawal of increment**--A draft will be prepared and discussed with the Association and then put up for consideration to Dir (HR).
7. **Including working spouse in Medical OPD Scheme**—Case will be put up next week.
8. **Increment to 2003 batch JTO/AM(T) on promotion**—Your good self will go through the representation made by affected officers and decide accordingly.
9. **Official Language pay scale & promotion issue**—Issue will be further deliberated at higher level to take decision on this issue
10. **Pending seniority and antedating cases in the cadre of SDE**--We brought the pending issues to your kind notice and some specific cases were also referred like Shri D S

Prasad, JTO Mumbai, B R Yadav SDE Mumbai, 12 cases of SC/ST special drive cases whose date of promotion in SDE cadre is to be antedated
