**Subject:** Illegal and unconstitutional misuse of our Association (MTNL Executives' Association, reg No-ALC/ Karyasan-17/9715 dated 31-01-2001) name, logo & Reg no by some miscreant officers of Mumbai unit.

Respected sir

We have come to know that neither certain miscreant officers of MTNL Mumbai unit who are neither office bearers nor even members of our Association are fraudulently misusing the name of our Association, MEA (MTNL Executive Association) by writing letters to management and collecting money from officers by posing themselves as office bearers of MEA Mumbai unit. We have already brought this fraudulent and illegal act to the knowledge of MTNL corporate office and Mumbai unit administration vide our letter no MEA CHQ/DM/ED/Mumbai Dated 20-11-14 but no administrative action has been taken to stop this fraudulent, unconstitutional & illegal act.

Our Association is registered vide Reg No- ALC/Karyasan-17/9715 dated 30-01-2001 at Mumbai and as per clause 3(f) (i) of the constitution, Association functions at 3 levels ie Central Head Quarter (CHQ), Circle & Division. Central Head Quarter of the Association is in Delhi and General Secretary is the Chief Executive of the Association. Chief Executives of Circle Organizations in Delhi & Mumbai are Circle Secretaries. As per clause 3(f) (ii) of the constitution, each elected body in an organizational level shall be recognized by next higher body in the organizational level. So I as General Secretary, Central Head Quarters have recognized the MEA Mumbai Circle representative body elected in Mumbai Circle Conference held on dated 05-01-15 in which Shri J N Upadhyay, Shri G P Yadav & Shri D J Shelare are the Circle President, Circle Secretary & Circle Treasurer respectively of MEA Mumbai Circle vide my letter no- MEA/CHQ/DM/ED/Mumbai dated 06-01-15. So anybody other than these office bearers posing as President, Secretary and Treasurer of MEA Mumbai is illegal & unconstitutional.

**This type of illegal, unconstitutional & fraudulent act by certain vested interest officers spoils the working atmosphere in the company. So, appropriate action must be initiated against the officers who are involved in this fraud.**
