#### PROMOTION ORDER

- 3. The promotion shall be effected notionally w.e.f. 04/01/2010. However, actual financial benefits may be accorded with effect from the date the Officers assume charge in the grade of Dy. Manager (Telecom) The promoted Officers, if already working in the grade of Dy. Manager (Telecom) on local officiating basis, should be reverted back on 03/01/2010 before promoting them on regular basis.
- 4. The pay of the Officers on promotion shall be regulated under FR 22 (I) (a) (1).
- 5. The Officers are required to join the promoted post within the prescribed period of 40 days from the date of issue of this Order.
