### (A) VOCATIONAL TRAINING:

- (E) The training charges applicable as per above plus service tax as applicable (at present 10.30%) should be deposited in the office of Accounts Officer (Cash), HQ, MTNL, Eastern Court complex, New Delhi in cash or by Demand Draft drawn in favour of MTNL Delhi payable at New Delhi.
- (F) Vocational / Industrial training will be provided by Institute of Telecom Technology & Management, MTNL, Telephone exchange building, Shadipur, New Delhi-110008.
