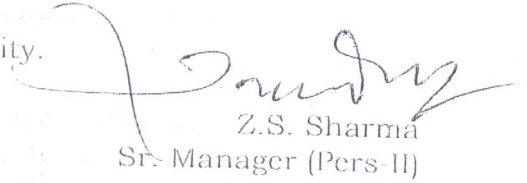
Sub: Regarding Screening Report & Vigilance Clearance for promotion to the grade of EE/Sr. Manager (Civil)
